Maplewood Noise Control

No person shall make or cause to be made any distinctly and loudly audible noise that unreasonably annoys, disturbs, injures or endangers the comfort, repose, health, peace, safety or welfare of any person or precludes their enjoyment of property or affects their property's value. There shall be no excessive noise or disturbance between the hours of 7:00 p.m. and 7:00 a.m. Monday through Saturday and all day Sunday. These hours of prohibition apply to construction, business, institutional and residential activities.

The following noise generating activities which are necessary and typically occur in all parts of the city during daylight hours, but not before 7:00 am, are allowed: lawn mowing, the use of landscape-maintenance equipment, power tools, etc; all forms of snow clearing may be permitted anytime due to necessity. If there is an event or activity that is sponsored by the City, or a party has a permit for a noise-generating activity issued by the city, the noise prohibition above does not apply.
